The City Council of the City of Camanche, Iowa met in regular session January 6, 2015 at 6:00 P.M. at Camanche City Hall. Present on roll call: Mayor Fahlbeck, presiding, and the following named council members: Willis, McManus, Lind, Varner and Wruck. Also present were City Administrator Roth and department heads Houzenga, Schutte, and Jindrich.

A moment of silence was observed. Mayor Fahlbeck led the Pledge of Allegiance.

Moved by Willis, second by Lind to approve the agenda. On roll call – all ayes.

Jindrich explained to the council the reasoning behind the Resolution Closing and Directing the Transfer of Fund to Close out 9th Street Recreation Trail Capital Project and the Washington Boulevard Capital Project Fund. Lind also questioned Item #5 – the completion date on the Tax Abatement as submitted by Elizabeth and Chad Macke. He was told that the completion date is correct.

Approve Class B Wine, Class C Beer Permits and Sunday Sales as submitted by Dollar General; approve reappointment of Melvin Albrecht to Planning & Zoning, term expires January 2020; approve Application for Tax Abatement as submitted by Elizabeth and Chad Macke – 1209 23rd Avenue; receive, accept and place on file minutes from Rose Hill Cemetery Board meeting held December 7, 2014, Library Board meeting held December 3, 2014; approve a Resolution Closing and Directing the Transfer of Funds to Close the 9th Street Recreation Trail Capital Project Fund and the Washington Boulevard Capital Project Fund; approve Change Order #5 – Credit of \$23,935.14 and Pay Estimate #5 Final in the amount of \$20,287.99 to Determann Asphalt for the 9th Avenue Curb and Reconstruction Project. On roll call – all ayes.

Negotiations – the next meeting with the Bargaining Unit will be January 19, 2015.

Clinton County's Proposal to Annex Property to the Cities of Clinton and Camanche – Roth stated that the City Development Board likes clean straight lines. They would probably give parcels 1-4 to the City of Clinton. The Council would like Roth to prepare a request to the City Development Board that the City would be interested in Parcels 1, 4 and 11. The City's argument would be that it would give the city access to S 54th Street and Highway 30.

Moved by McManus, second by Varner to have Roth contact the City Development Board under the Iowa Economic Development Authority to request Parcels 1, 4 and 11 are annexed to the City of Camanche. On roll call – all ayes.

Roth reported that Planning and Zoning will be meeting next week to go over zoning restrictions around the airport. ECIA has prepared an ordinance that the council will have to adopt.

Storage/Community Center – a committee met with Dale Juck of Wick Building. Dale will go back and draw something up. He estimated the price to be about \$250,000 - \$300,000. There is a grant available for an asbestos study and concrete removal if Garner Hall gets town down.

Budget - Roth commented that there will be a budget workshop next Tuesday. The city's contribution to the 411 pension has gone down; the Public Works department budget has changed with Rickertsen retiring and the hiring of Troy. Negotiations are not done yet though and the budget needs to be certified by March 15, 2015. The budget meeting will be 5:00 on January 13, 2015.

Fahlbeck asked Varner if the Historical Board knows about the possibility of the demolition of Garner Hall. Varner will bring it up at Thursday's meeting.

Lind stated he had gotten a call from a resident on 3rd Street that said the Christmas light is out on 13th Avenue. Hilgendorf reported that a GFI was out.

Houzenga reported that the body cameras have arrived and are in use.

Roth informed the council that Brent Holstein gave the City the clock that was on the Litehouse. Roth would like to get it fixed and mount it on the new City Hall.

Roth showed the council a light (1 of 6) that was given to the City by Dave Willis. Everyone agreed they were too big to put on the new City Hall. They agreed to put the lights in the triangle piece of ground for the Washington Boulevard Project.

At 6:34 P.M., being no further business, the Mayor declared the meeting to be adjourned.
