

ORDINANCE _____

AN ORDINANCE AMENDING THE CAMANCHE, IOWA MUNICIPAL CODE BY AMENDING CHAPTER 2-12-6, AND REPEALING CHAPTER 2-12-9

Section 1. **Purpose.** The purpose of this ordinance is to amend the Camanche Municipal Code by modifying the powers and duties of the Camanche Park and Recreation Commission.

Section 2. **Facts Found.** The City Council of the City of Camanche, Iowa hereby makes the following findings of fact:

- 1) Ordinance 2-12-6 Section 2 of the Camanche Municipal Code provides that the Camanche Park and Recreation Commission shall have control over City parks.
- 2) Ordinance 2-12-6 Section 3 of the Camanche Municipal Code provides the Camanche Park and Recreation Commission control over all affairs of the Commission
- 3) Ordinance 2-12-6 Section 4 and Subsection 5 of the Camanche Municipal Code provides the Camanche Park and Recreation Commission authority of a Director and employees
- 4) Ordinance 2-12-6 Section 7 provides the Camanche Park and Recreation Commission authorization for use of Garner Hall by non-residents
- 5) Ordinance 2-12-6 Section 8 provides the Camanche Park and Recreation Commission authority over bylaws of Garner Hall
- 6) Ordinance 2-12-6 Section 9 of the Camanche Municipal Code provides the Camanche Park and Recreation Commission control over rentals collected.
- 7) The City Council of the City of Camanche expresses final authority over control of City property, including parks.
- 8) The City Administrator, under direction of the City Council of the City of Camanche, has authority over personnel under Camanche Municipal Code 2-17-4 Subsection 5.
- 9) Garner Hall is no longer a functioning facility and is in process of demolition.
- 10) All boat ramps are handled through City Hall and Public Works.

Section 3. **Amendment.** Chapter 2-12-9 is repealed. Chapter 2-12-6 Sections 1 through 13 are hereby deleted and the following language is inserted in lieu thereof:

2-12-6 POWERS AND DUTIES. The board shall have and exercise the following powers and duties.

1. To meet and elect from its members a chair person, a secretary and such other officers as it deems necessary.
2. To have charge and supervision of all city parks and city recreation equipment.
3. To direct and manage all the affairs of the Park and Recreation commission.
4. To select and purchase all items considered necessary for the operation of the Camanche Park and Recreation Commission.
5. To direct and plan changes to park functions or usage as directed by City Council.
6. To manage the expenditures of all portions of the general fund allocated for recreational purposes by the Council.
7. To make and send to the City Council, on or before the seventh day of January in each year, an estimate of the amount necessary for operation and maintenance of recreational facilities for the coming fiscal year, the amounts expended for like purposes for the preceding year, and the amount of income expected for the next fiscal year from sources other than taxation.
8. To enforce the performance of conditions on gifts, donations, devises, and bequests accepted by the City by action against the City Council.
9. To keep a record of its proceedings.
10. To perform all of the functions, duties and obligations as designated regarding trees and shrubs, as now and hereafter amended.

Section 4. **Repealer.** All ordinances or parts of ordinances in conflict with any provision of this ordinance are hereby repealed.

Section 5. **Severability Clause.** If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect this ordinance as a whole, or any section, provision, or part thereof not adjudicated invalid or unconstitutional.

Section 6. **When Effective.** This ordinance shall be in full effect from and after its final passage, approval, and publication as required by law.
