

City of Camanche

July 17, 2018

The City Council of the City of Camanche, Iowa met in regular session July 17, 2018 at 6:00 p.m. at the Camanche City Hall. Present on roll call: Mayor Willis, presiding, and the following named council members: Metzger, Varner, Campie, Weller and Brightman. Also present were City Attorneys John Frey and Randy Current, City Administrator Andrew Kida, department heads Hilgendorf, Schutte, Reid and Schneider.

A moment of silent prayer was observed. Mayor Willis led the Pledge of Allegiance.

Moved by Weller, second by Varner to approve the Agenda. On roll call – all ayes.

Brenda Larkey from Camanche Days addressed the Council. She thanked everyone for their support and shared some information about this year’s event, which will be held August 2 through August 5. The car show and pedal pull have moved to Sunday and the 5k will be held on Saturday. Kickball will be added this year and there will be entertainment each night. Event t-shirts are for sale to help raise funds. She stated that costs for tents, bathrooms and insurance have all increased and they have lost a major sponsor. She asked if the Council would like to help. We have budgeted \$3,000. Varner asked if we could give more considering the increased costs. Kida said he would look at it. Metzger said in the future we could consider increasing at budget time. Larkey mentioned this is the 39th year under Camanche Days, Inc. so next year they want to do it even bigger for the 40th year.

Receive, accept and place on file revised minutes from the Park & Recreation Commission meeting held on June 4, 2018 and minutes from the meeting held on July 2, 2018; Receive, accept and place on file minutes from the Cemetery Board meetings held on June 11, 2018 and July 9, 2018; Receive, accept and place on file minutes from the Library Board meeting held on June 6, 2018; Accept the City Clerk/Treasurer's report for May 2018 which includes the following receipts: General-\$69,515.22 Library \$12,706.69 Parks-\$4,871.08 Cemetery-\$3,149.41 Road Use-\$43,710.90 Employee Benefit-\$705.99 Police & Fire Pension-\$1,370.44 Edens TIF-\$42.17 P.C. & R. On roll call – all ayes.

Moved by Varner, second by Weller to approve the Application for Permit to Operate a Golf Cart on Camanche City Streets as submitted by Gary Tucker. On roll call – ayes Campie, Brightman, Varner and Weller. Abstain – Metzger.

Mayor Willis read a Resolution authorizing the City Administrator to issue Golf Cart Permits. Permits would be issued by the City Administrator in accordance with the Ordinance after inspection by the Police Department. The application has been revised for the inspection.

Moved by Weller, second by Metzger to approve a Resolution to Authorize the City Administrator to issue Golf Cart Permits. On roll call – all ayes.

Mayor Willis read a Resolution establishing a fee for golf cart permits. The fee to obtain a permit would be \$50 annually, payable in April of each year. The permits previously approved would not need to pay this year but would need to begin paying the annual fee in April 2019.

Moved by Weller, second by Campie to approve a Resolution, as amended, to Establish a Fee for Golf Cart Permits. On roll call – all ayes.

Mayor Willis read a Resolution authorizing an Easement Agreement between the City of Camanche, Iowa and Marshall L. Richardson and Carolyn A. Richardson for construction of a sea wall on public property at 5th Avenue. Kida stated the public hearing was held at the last City Council meeting and there were no public comments. The Richardsons will maintain the grassy area and sea wall; the City retains ownership of the property and access to the riverfront and the dock that is there.

Moved by Varner, second by Weller to approve a Resolution Authorizing an Easement Across City Property Benefitting Parcel ID 1000770000 for the Construction of a Sea Wall/Retaining Wall on Parcel ID 1000770100. On roll call – all ayes.

Willis and Kida led a discussion regarding the School Resource Officer. Kida said the special joint meeting between the Council and the Camanche Community School Board regarding the establishment of a School Resource Officer at the Camanche Community Center on June 27, 2018 went very well. Discussion regarding paying for the officer, which would be a 9th officer, was discussed. The officer would be at the schools during the school year and with the city during the rest of the year and as needed during the school year. If the program were to begin in January, with the 8th officer not starting until September and if the Chief forgoes the currently budgeted administrative assistant, we could fund our portion of the SRO out of the current budget. The question is how to fund it in FY20. Kida believes with property value increases, the money will be there. Willis said there will be further discussion of how the costs will be shared with the school district. It will require a 28E agreement and a vote by the council after development of the agreement. The entire process will be lengthy.

Chief Reid read the Camanche Police Department June Report and Chief Schutte read the Camanche Fire Department June Report.

Kida reminded everyone of the Park Vista grand opening at 5:30 p.m. on July 19th. At the IACMA conference he attended, the former City Administrator from Ferguson MO spoke making Kida re-think how we operate as an organization. The rebranding survey is complete and he is compiling the data. He is working on the ADA Transition Plan with Linda Putman from the Park and Recreation Commission. He also noted that Sharon Till retired at the end of June after 24 years of service.

Mayor Willis wants everyone to have a safe, fun Camanche Days.

Metzger asked about fixing the Peters dock and if fishing is allowed there. Hilgendorf said the dock is being repaired. Fishing is allowed there. She also asked for signs by the RV

station by Public Works. Hilgendorf is also working on this. She also expressed concern regarding the cemetery staff driving the tractor with gas cans in the bucket to the gas station. She wanted to confirm that no motorized vehicles are allowed on the bike trail. She asked Kida if there will be a packet given to residents who are approved for golf cart permits. He said yes. She also complimented Corporal Smith as well as the Fire Department for their work with the children in Camanche.

Weller commended the Police Department on training the new officers.

Brightman said he talked to citizens around Lum Park and the consensus is they don't want a dog park in their back yard.

Chief Reid said he applied for and was awarded a \$1,000 Lyondell grant.

Chief Schutte reminded everyone of the Pancake Breakfast on August 4, 2018.

Anthony Schultz stated he is 100% opposed to a dog park in a residential area.

At 6:57 p.m. the Mayor adjourned the meeting.
