City of Camanche November 5, 2019

The City Council of the City of Camanche, Iowa met in regular session November 5, 2019 at 6:00 p.m. at Camanche City Hall. Present on roll call: Mayor Trevor Willis, presiding, and council members Metzger, Varner, Campie, Weller and Brightman. Also present were City Attorneys John Frey and Randy Current, department heads Reid, Schutte and Schneider.

A moment of silent prayer was observed. Mayor Willis led the Pledge of Allegiance.

Moved by Metzger, second by Varner to approve the Agenda. On roll call – all Ayes.

Mayor Willis opened a Public Hearing to consider an amendment to Chapter 18 Camanche Code of Ordinances – Zoning – Small Cell Wireless Regulations at 6:02 p.m. In the absence of public comments, the Mayor closed the Public Hearing at 6:03 p.m.

Justin McClure addressed the Council regarding the Zoning Ordinance as it relates to home occupation. Mayor Willis informed the Council that he attended the meeting at which Mr. McClure asked the Board of Adjustments to allow him to have an auto repair business in his garage in a residential neighborhood. The Board told him this could only be approved with an ordinance amendment so he is asking Council to amend the ordinance. Council discussed the request in detail. Since such an amendment would apply to the entire city, not specifically to Mr. McClure, the Council agreed they would not amend the ordinance and stated the decision was not personal.

Receive, accept and place on file draft minutes from the Park and Recreation Commission meeting held on October 7, 2019; Accept Resignation from Ronald Emerson – Library Board – Effective October 28, 2019. On roll call – all Ayes.

Mayor Willis read the Second Reading of an Ordinance Amending Chapter 3-3-44 of the Camanche, Iowa Code of Ordinances Truck Routes with one change; the fee will be \$35 per 48-hour period and not \$35 per trip.

Moved by Metzger, second by Brightman to approve the Second Reading of and Ordinance Amending Chapter 3-3-44 if the Camanche, Iowa Code of Ordinances Truck Routes, as amended. On roll call – Ayes – Varner, Metzger, Brightman, Campie, Weller. Nays – none.

Parking on 8th Avenue at 6th Street was discussed. Mayor Willis said he talked to residents there and looked at the street with Hilgendorf, noting a large drop-off at the edge of the street. He suggests placing gravel in the right of way to level this off. Brightman asked where the water runs and is concerned it will wash out. Metzger is concerned about emergency vehicle and snow plow access if we allow the truck to park on the street. Varner said we inadvertently caused the problem when the street was resurfaced. It was agreed to try the gravel in the right of way.

Moved by Weller, second by Metzger to adopt a Resolution Setting a Date and Time for a Public Hearing Regarding Adopting the City of Camanche, Iowa Code of Ordinances. On roll call – all Ayes.

Moved by Metzger, second by Varner to suspend the rules of procedures to allow the First Reading of an Ordinance Amending Chapter 3-3-58, 3-3-59, 3-3-66 and 3-3-70 of the Camanche, Iowa Code of Ordinances Snowmobiles, Off Road Vehicles and Golf Carts by Title Only. On roll call – all Ayes.

Metzger said she has had calls from people who want the time frame back in the snowmobile ordinance. We will see how it goes and address it if there is a problem. Mayor Willis said the state does not recognize lawn mowers as road-worthy vehicles so we are going to continue status-quo and leave them out of the ordinance allowing them to go job to job.

Kida gave a presentation recapping Phase I of the Street Improvement Plan and showed details of Phase II. He requested approval of the amendments of Phase II so we can put it out for bid in the next couple of months.

Kida said Council has the option of sending out an RFP for legal services or renewing with Frey, Haufe and Current. Varner said they are doing an excellent job. Metzger said they are great at communication and recommends keeping them. Weller agrees. Brightman would like an RFP. They will provide a rate schedule.

Moved by Metzger, second by Varner to Approve Payment of Superior Seawalls, Docks & Dredges Invoice for balance of tree and brush removal – Library Dock \$20,020.00. On roll call – all Ayes.

Chiefs Reid and Schutte read the Camanche Police and Fire Department reports for October.

Kida said there will be a preconstruction meeting this week on the sewer project. He recognized anniversaries for himself 3 years and Schneider 2 years. He also thanked all veterans for their service.

Metzger asked if citizens can donate to the smoke detector fund; Chief Schutte said yes. She said \$1,726.26 was raised for the Sharing Tree. Varner thanked veterans for their service. Campie talked about the Senior Committee survey, list, ideas and communication. Weller said the Santa House has received significant donations and will happen. Brightman said the crosswalks look good.

Mayor Willis adjourned the meeting at 7:21 p.m.
