## **CITY OF CAMANCHE, IOWA EMERGENCY PROCLAMATION**

WHEREAS, COVID-19 poses a serious threat to the public health and safety of the City of Camanche, Iowa, as outlined by the Center for Disease Control ("CDC"); and

WHEREAS, the Iowa Department of Public Health ("IDPH") has now determined that community spread of COVID-19 has occurred in the State of Iowa; and

WHEREAS, the Hon. Governor Kim Reynolds has ordered a State of Public Health Disaster Emergency and extended said emergency effective noon November 16, 2020; and

WHEREAS, Section 372.14(2) of the Code of Iowa (2019) grants the Mayor powers to declare an emergency and govern through proclamation to protect the health and safety of the citizens of Camanche.

NOW, THEREFORE, I, Trevor Willis, the duly elected Mayor of the City of Camanche, Iowa, do hereby proclaim the following:

1. That a state of emergency or public danger continues to exist within the City of Camanche because of the threat of the spread of the COVID-19 virus.
2. That all orders from the Governor's proclamation dated November 16, 2020 are in effect within the City of Camanche, Iowa including the gathering restrictions at all public parks and pavilions.
3. That all other public health safety measures as outlined in the Governor's proclamation on November 16, 2020 including directions on mask use; social, community, business or leisure gatherings; sporting and recreational events; high school sports & extracurriculars; restaurants and bars; bowling alleys, pool halls, bingo halls, arcades, indoor playgrounds and

children's play centers be adhered to

4. That the following facilities be closed to the public until further notice:

Camanche City Hall  
Camanche Fire Department  
Camanche Police Department  
Camanche Public Library  
Camanche Public Works  
Camanche Community Center  
Yard Waste Collection

5. That this Proclamation of Emergency may be modified and/or superseded by future proclamation of the Office of the Mayor of Camanche as future events warrant.

6. That any violation of any proclamation of the Office of the Mayor of the City of Camanche, Iowa, shall be enforceable by the Camanche Police Department and any violation of the same shall be a violation of Title 1 Section 3 of the Camanche Code of Ordinances and punishable as a simple misdemeanor.

7. That any violation of Title 1 Section 3 of the Camanche Code of Ordinances under this order shall be set at the maximum allowable fine.
